Join us at the clubhouse on Memorial Day to meet the coaches, register for swim team, and purchase your swimsuit, goggles, and fins. Our parent meeting will be held at 4:00 p.m. A separate Little Piranha parent meeting will be held at MHC on Sunday, June 1st, at 7 p.m.

## SWIM COACHES

We are pleased to welcome back Head Coach Joe Smolinske to MHC. He grew up swimming in the Northern Virginia Swim League (NVSL) at Hayfield Farm and has been coaching competitive swim teams since 2005. He was an NCAA student-athlete at the University of Wisconsin-Whitewater. Joe is currently in graduate school at Xavier University and works as an assistant coach with Nation's Capital Swim Club.

Marye Carter will be returning as our Assistant Head Coach. Coach Carter has been developing younger swimmers since 1991. She has provided swimming and exercise instruction for Fairfax County, Nation's Capital Swim Club, and the NVSL. She is currently a kindergarten instructional assistant at Riverside Elementary and a lead coach for Nation's Capital Swim Club.

## MEETS

The Piranhas kick off our 2014 season with Time Trials on Saturday, June 14<sup>th</sup> at 9am. This meet lasts about two hours and gives swimmers an opportunity to get times in each of the competitive strokes—freestyle, backstroke, breaststroke, and butterfly.

MHC will compete in Division 7 of the NVSL this season. Our opponents for our five competitive Saturday meets are Dowden Terrace, Great Falls, Greenbriar,

Holmes Run Acres, and Waynewood. MHC will host Division Relays and Greenbriar will host the Division Individual Championship. NVSL All-Star Relays will be at Hunt Valley and NVSL Individual All-Stars will be at Annandale.

We have also scheduled 5 Monday night Developmental Meets, "B meets", against Fort Hunt area teams including MVCC, Hollin Meadows, Hayfield Farm, Mount Vernon Park, and Waynewood. Other local qualifying meets include the Fort Hunt Sportsmen's Relays at Stratford Landing and the IM Invitational at Stratford Landing. Come out to cheer your swimmer and see friends from local pools.

**After School practice** begins Tuesday, May 27<sup>th</sup> with 13-18 year-olds practicing from 4:00-5:00p.m., 9-12 year-olds from 5:00-5:45 p.m., and 8 & Under from 5:45-6:30 p.m. **Morning practice begins Thursday, June 26<sup>th</sup>.** It will be 7:30-9:00 a.m. for 13-18 year-olds; 8:45-10:00 a.m. for 9-12 year olds; and 9:45-10:45 a.m. for 8 & Unders. **Quick Start 1**—Ages 4-6 (Program Code QS1): The newest players will learn tennis tailored to their size and age. Special balls, nets, and court dimensions will be used to ensure everyone has fun and learns the fundamentals.

**Quick Start 2**—Ages 6-8 (Program Code QS2): This is a continuation of Quick Start 1, still using special balls and smaller court dimensions, but with more advanced drills and games for younger players.

programs in Northern Virginia. Our dive team philosophy is to become the best divers we can, to demonstrate good sportsmanship and team spirit, and to have a fun and safe summer. If you are new to diving, and don't yet know if your child will like it, or commit to it, please come try it out! Everyone is offered the chance to try it for a week. If it's not right for your child, your check will be returned to you at the end of the first week of practice. We do need your registration form and check in hand, however, to comply with our insurance regulations. So, come on May 26<sup>th</sup>, ask questions, learn more about diving, fill out a registration form, write the check, and then come to practice for a week. We promise you'll be hooked! We've had children as young as four on the team, so don't let age be an issue. The younger they start, the better! After you've tried it for a week, you'll know if it's right for your child, and if not, we'll return your check, and hope you'll try it again another year.

## OFFICIALS CLINICS

Do you enjoy having the best seat in the house? Do you like being part of the action? Then dive table working and judging are perfect for you! Table workers help run the meet by writing the scores and degrees of difficulty on the sheets after each dive, and then they tabulate the diver's score. Judges sit by the side of the pool and rate each dive on a scale of one to ten. In order to learn how to do these very important roles, there are clinics that will teach you everything you need to know.



**The MHC dive team needs more parents, especially those of younger children, to learn how to referee, judge, announce, and work the table.** To do so, you'll need to attend one of the clinics listed on the **DIVE TEAM CALENDAR**.
